


Area of Review

Item VIII:

Disposal will be into the Delaware Mountain Group (Delaware). The Delaware is comprised of sandstones, dolomites, and shales. The proposed disposal interval is in the Bell Canyon and the Cherry Canyon. All the Delaware members are interbedded sandstones and shales with occasional dolomite horizons. The lateral transmissivities of the sandstone beds are highly variable and often form selective barriers to the movement of hydrocarbons while allowing down-gradient movement of water. The transmissivity variations are fundamentally due to 1) the very-fine grained nature of the sands and 2) the local percentage of silt and clay. The Delaware sandstone members are typically overlain and underlain by bounding shale, dolomite, and/or silty shale horizons. The depth to the Delaware Ramsey sand in this well will be approximately 4,790'. The base of the Delaware (top of Bone Springs Formation) is estimated at approximately 8,850', well below this well's projected TD of approximately 7,350'.

There is no known fresh, potable water within a 2-mile radius. Records from the New Mexico Office of the State Engineer on 6/17/2013 show no known water wells within the 2-mile radius of the proposed Mesquite SWD disposal well.
