Mr. Ezeanyim and I met with the Director this morning.

Her position is that this is something that can be done if all owners agree, but that the project areas formed in this way cannot be compulsory pooled.

Accordingly, this can be done only if you can get agreement of all owners. Procedurally, it will require the formation of two non-standard, 320-acre proration units in Section 14. This will require filing a non-standard proration unit (NSP) application, and giving notice pursuant to Rule 19.14.4.12.A(3). These non-standard proration units can then be combined with standard proration units comprising Sections 15 and 13, respectively. New notices for the non-standard proration units will have to be given because the notices your previously sent erroneously referred to a 1280-acre unit. In addition appropriate notices will need to be given for the non-standard location (NSL) application pursuant to Rule 19.15.4.12.A(2).

Good Afternoon, Mr. Walsh

We received the referenced application for non-standard location approval of an approximately one and one-half mile horizontal well to be drilled in Sections 14 and 15 of 25N-2W in Rio Arriba County, in the Gavilan Mancos Pool.

You have attached a notice to offsets which correctly, in accordance with Rule 19.15.16.16.E, proposes a 1280-acre nonstandard project area comprising all of Sections 14 and 15. This is a non-standard project area than can be formed under that rule in a pool spaced on 640 acres. If you certify to us that no one has communicated any objection to the proposed non-standard project area, we can proceed to consideration of the NSL application.

However, there are two problems with your proposed NSL application. First, the plat you furnished shows the "Proposed Non-Standard Project Area" as comprising only the W/2 of Section 14, and Section 15 and consisting of 960 acres. This cannot be done under Rule 19.15.16.16, because that rule does not authorize division of spacing units, and in a pool spaced on 640 acres, all of Section 14 would constitute a single spacing unit. Designating a 1280-acre NSPA, as you do in your attached notice letters, would not preclude you from later proposing a NSPA comprising all of Sections 13 and 14 for your suggested future wells to the east, since project areas may overlap. Alternatively, you could file a separate application to form two non-standard 320-acre spacing units in Section 14. However, that procedure would require that you re-propose you NSPA as a 960-acre NSPA. Simplest would be to furnish us a new plat indicating a 1280-acre NSPA, as in your notice letters.

Second, you have not dealt with the issue of the required notices to owners in Section 16 of the encroachment proposed to the west by your non-standard location. Please advise if Hunt Oil is the owner of the working interest in Section 16. Otherwise you will need to send notices to the owners in that section specifically calling their attention to the proposed encroachment and admonishing them that any objection must be filed with OCD within 20 days following your notification.

Hunt Oil Company (Hunt) is proposing to drill two horizontal wells to test the Mancos Formation in Sections 13, 14 and 15, Township 25 North, Range 2 West. The <u>Regina Com 25-2-14-15 #1H</u> is to be 14,545' MD (7,218' TVD). The surface location is to be 1443' FSL and 2262' FEL of Section 14. The lateral is to be 7,000' long, running east to west. The bottom hole location is to be 2023' FSL and 462' FWL of Section 15.

The <u>Regina Com 25-2-14-13 #1H</u> is to be 13,840' MD (7,220' TVD) in Sections 13 and 14, Township 25 North, Range 2 West. The surface location is to be 1421' FSL and 2257' FEL of Section 14. The lateral is to be 6,655' long, running west to east. The bottom hole location is to be 2013' FSL and 430' FEL of Section 13. Both of these wells are oil tests in the Gavilan-Mancos Pool.

The standard spacing unit for the Gavilan-Mancos Pool is 640 acres. To facilitate the drilling of the wells, Hunt is proposing 960 acre Project Areas (PA's) by forming two 320 acre Non-Standard Proration Units (NSPU's), in the west half of section 14 and the east half of section 14. The NSPU's will be combined with all of sections 15 and 13 respectively to form the two PA's. The PA's are necessary due to the 7,000' and 6,655' lateral lengths which are essential for economic wells.

Hunt is also proposing Non-Standard Locations (NSL's) within the above PA's. The setbacks for the Gavilan-Mancos Pool are 790'. Hunt is requesting setbacks of 330' at the heel and toe of the laterals. The length of the lateral will be 2,013' from the south lines of the PA's. Therefore the proposed encroachment on the standard setbacks only occurs on the east and west lines of the PA's. This encroachment is necessary, because without it there will be a distance of 1580' separating the toe of the proposed well with the toe or heel of additional horizontal wells that may be drilled in the offsetting tracts. This would represent significant waste of undeveloped oil and gas. This situation is exacerbated by the fact that the direction of maximum stress in this area is north-south, meaning that fractures (both natural and induced) trend north-south. The cumulative effects of the standard setback distances and the trend of fracturing would render a significant north-south strip of acreage impossible to develop as oil and gas productive. Operators of offsetting tracts within 790' of the proposed encroachment will be contacted by certified letter.

If approved, the two PA's facilitate the development of three full sections of land (1920 acres) that could be developed by eight wells from two pads. This would minimize the surface impact of our operations including total pad area, access roads, and pipeline right of ways.

Developing HOC's acreage position in the San Juan Basin with NSL's and PA's is an efficient plan that minimizes reserve waste, allows for economic wells, and maintains good stewardship of the environment.
