

APPLICATION

Legend Natural Gas III, LP applies for an order establishing special rules and regulations for the North Hay Hollow-Bone Spring Pool (the "Pool"), and in support thereof, states:

1. Applicant is an operator in the Pool (Pool Code 30216).
2. The Pool was established by Division Order No. R-8065, and currently includes, or is proposed by the Division to include, the following acreage:

Township 25 South, Range 27 East, N.M.P.M.

Section 12: All
Section 13: All
Section 23: E/2
Section 24: All
Section 25: All
Section 26: E/2

Township 25 South, Range 28 East, N.M.P.M.

Section 7: E/2
Section 17: W/2
Section 18: All
Section 19: All
Section 20: W/2
Section 29: W/2
Section 30: All


The Pool has a depth bracket allowable of 107 barrels of oil per day for a standard 40 acre oil spacing and proration unit, with a statewide producing gas:oil ratio of 2000:1.

3. Horizontal wells in the pool are capable of producing in excess of the Pool's depth bracket allowable, without waste.

4. Applicant requests that:
- (a) Special rules and regulations be enacted for the Pool, providing for a special depth bracket allowable of 375 barrels of oil per day for a standard 40 acre oil spacing and proration unit; and
 - (b) All other rules remain in conformance with statewide rules.
5. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division grant the relief requested above.
