APPLICATION

Mewbourne Oil Company applies for an order (i) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the N½N½ of Section 9, Township 20 South, Range 29 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

- Applicant is an interest owner in the N½N½ of Section 9, and has the right to drill 1. a well thereon.
- Applicant proposes to drill its Perazzi 9 DA Fed. Well No. 1H to a depth 2. sufficient to test the Bone Spring formation. Applicant seeks to dedicate the N½N½ of Section 9 to the well to form a non-standard 160 acre oil spacing and proration unit (project area) in the Bone Spring formation for all pools or formations developed on 40 acre spacing within that vertical extent. The well is a horizontal well, with a surface location 920 feet from the north line and 150 feet from the east line of adjoining Section 8, and a terminus 920 feet from the north line and 330 feet from the east line of Section 9.
- Applicant has in good faith sought to obtain the voluntary joinder of all other 3. mineral interest owners in the N½N½ of Section 9 for the purposes set forth herein.
- Although applicant attempted to obtain voluntary agreements from all mineral 4. interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners in the N½N½ of Section 9, pursuant to NMSA 1978 §§70-2-17, 18.

5. Approval of the non-standard unit and the pooling of all mineral interests underlying the N½N½ of Section 9 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Approving a non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the N½N½ of Section 9;
- B. Pooling all mineral interests in the Bone Spring formation underlying the N½N½ of Section 9;
- C. Designating applicant as operator of the well;
- D. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;
- E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- F. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.
