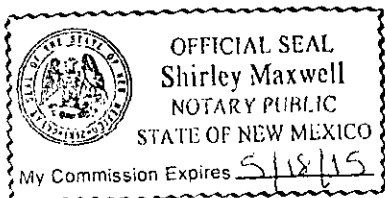

To: Isaac Kawasaki, Charles Cline, Moore, or their successors, heirs, or devisees, Devon Energy Production Company, L.P. has filed an application with the New Mexico Oil Conservation Division seeking an order approving a 160-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the E/2E/2 of Section 14, Township 21 South, Range 27 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard spacing and proration unit (project area) for any formations and/or pools developed on 40-acre spacing within that vertical extent. The unit is to be dedicated to the Lone Tree Draw 14 State Com. Well No. 1, a horizontal well to be drilled at a surface location 335 feet from the south line and 1110 feet from the east line of adjoining Section 11, with a terminus 330 feet from the south line and 810 feet from the east line of Section 14. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, February 20, 2014 at the Division's

ices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in the well unit you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date. The attorney for applicant is James Bruce, P.O. Box 1056, Santa Fe, New Mexico 87504. The unit is located approximately 6 miles northeast of Carlsbad, New Mexico.
