




Ladies and gentlemen:

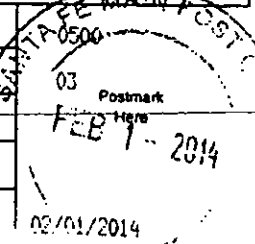

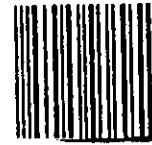

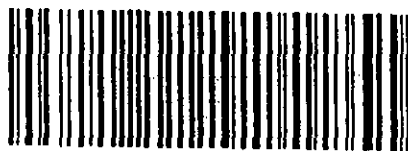
