
Mewbourne Oil Company applies for an order pooling all mineral interests in the Morrow formation underlying the N½ of Section 10, Township 17 South, Range 28 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

1. Applicant is an interest owner in the N½ of Section 10, and has the right to drill a well thereon.
2. Applicant has drilled its Hiawatha Fed. Com. Well No. 1, at an orthodox location in the SW¼NW¼ of Section 10; to a depth sufficient to test the Morrow formation, and seeks to dedicate the N½ of Section 10 to the well to form a standard 320 acre gas spacing and proration unit in the Morrow formation (Southeast Crow Flats-Morrow Gas Pool).
3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the N½ of Section 10 for the purposes set forth herein.
4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in the N½ of Section 10, pursuant to NMSA 1978 §70-2-17.
5. The pooling of all mineral interests underlying the N½ of Section 10 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the N½ of Section 10 in the Morrow formation;
- and
- B. Designating applicant as operator of the well.
