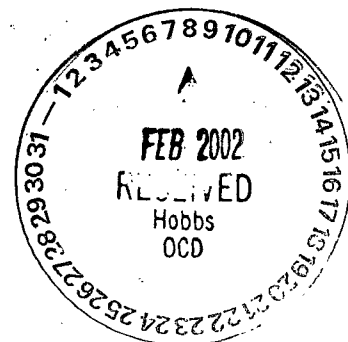
Penroc is filing the attached change of operator form from Professional to Penroc effective this date and intend to return to production after a work over within the next 90 days. Thank you.




