STATEMENT OF THE CASE

WPX seeks an order (1) approving it’s South Chaco Federal Exploratory Unit pursuant to 19.15.20.14 NMAC; and (2) for an exception to the well location requirements in the Special Rules for the Basin Mancos Gas Pool to allow WPX to locate wells anywhere within the Unit so long as the completed interval is no closer than 330 feet to the outer boundary of the Unit Area. This proposed federal exploratory unit consists of approximately 1,282 acres of Indian allotted

lands located in approximately 3 miles Southeast of Lybrook, New Mexico, and the unitized interval includes all formations from the top of the Mancos Shale (base of Mesa Verde Group) at a measured depth of 4,571 feet to the base of the Greenhorn Limestone formation (top of the Graneros Shale) at a measured depth of 6,456 feet as shown in the Quinella #1 well (API No. 30043200770000).
