Summary of owner history and attempts to locate and contact to obtain signature on a Communitization Agreement covering the Bone Spring formation proration unit of the N/2 N/2 production from the Devon operated 'Antares 23 Fed Com 1 H'.

- #1 Original Lessee in 1953 was 'Don and Gladys Angle', 510 W Texas, Artesia, NM 88210.
- #2 Through 1981 Gladys Angle probate proceedings and a 1983 Deed of Distribution, ownership passed to Evelyn Angle Holmstrom.
- #3 Through a December 2009 Deed of Distribution, ownership passed from Philip V. Swan as Personal Rep. of the Estate of John A Holmstrom to Carolyn Holmstrom, Trustee of the John A. Holmstrom 2004 Trust.
- #4 As of current date, the owner is Richard Jackson, Trustee of the John A. Holmstrom 2004 Trust.

Attempts to contact owner:

- #5 The 2009 Deed, signed by Philip V. Swan, lists address of "Carolyn Holmstrom, 2925 Somerset Place, San Marino, CA 91108-3035".
- #6 A phone listing for 2925 Somerset Place of #626-681-7379 is not a working number.
- #7 2/14/2014 Federal Express package mailed to 2925 Somerset Place was returned "incorrect address – recipient moved".

#8 Phone listing in San Marino, CA for Philip Swan is #626-792-7522. A call on 3/14/2014 to this number resulted in current resident saying Swan does not live there and they do not know him.

The subject lease also covers lands in Section 13-19S-31E which has production from wells operated by Legacy Reserves located in Midland, TX. Legacy is currently issuing revenue checks to "Richard Jackson, Successor Trustee of the John Holmstrom 2004 Trust, P.O. Box 90727, Pasadena, CA 91109".

#9 Could not locate a phone listing for Richard Jackson.

#10 2/20/2014 a package was mailed to the address via U.S. regular mail.

#11 4/03/2014 a U.S. Priority mail package was delivered to the address.

#12 To date, Richard Jackson has not responded to our correspondence.
