#### PRE-HEARING STATEMENT

Applicant Oil Conservation Division ("OCD") is seeking an order declaring:

- 1. That operator, Hal J Rasmussen Operating Inc., ("Rasmussen") is in violation of OCD Rules 19.15.15.9, 19.15.15.10, 19.15.25.8, 19.15.25.11, 19.15.16.8, and 19.15.29.8 NMAC.
- 2. That all Rasmussen's wells be shut in until operator complies with all division regulations by a date certain.
- 3. If Rasmussen does not comply with division order, the division will declare all wells abandoned, and authorize the OCD to plug and abandon the operators wells and recover costs from Rasmussen in accordance with OCD Rule 19.15.8.13 NMAC.
- 4. That operator is out of compliance with 19.15.5.9 (A)(4) by having 4 out of 12 well(s) out of compliance with 19.15.25.8.

The OCD supports the approval because of the following:

- 1. Notice of Hearing was properly served as required by 19.15.4.9 NMAC and 19.15.4.10 NMAC.
- 2. Rasmussen has posted financial assurance in the form of a \$50,000 blanket bond, bond no. RLB0012533, from RLI Insurance Co., for the amount of \$50,000 to secure its obligation to plug and abandon the well.
- 3. The officers of record of Platinum are Harold James Rasmussen (President) and Gregory J. Rasmussen (Vice President).
- 4. Operator has made no effort to contact the OCD regarding several compliance issues, and its officers are currently subject to division order R-13866.
