

3. Applicant has drilled a well in the W/2E/2 of Section 6, Township 25 South, Range 32 East, N.M.P.M., which was placed in the Pool by the Division. In addition, applicant has development plans under which additional Delaware wells will be drilled on acreage adjoining the Pool. As a result, applicant requests that the Pool be expanded to include the following acreage:

Township 25 South, Range 32 East, N.M.P.M.

Section 4: W/2 and SE/4


Section 5: All
