Docket Nos. 33-14 and 34-14 are tentatively set for October 30, 2014 and November 20, 2014. Applications for hearing must be filed at least 30 days in advance of hearing date. OCD Rule 19.15.4.13.B requires parties who intend to present evidence at an adjudicatory hearing to file a pre-hearing statement no later than the Thursday before the hearing, and serve a copy on opposing counsel of record. If the OCD does not receive a pre-hearing statement from the applicant by the close of business on the Thursday before the hearing, the hearing may be continued. A party who plans on using projection equipment at a hearing must contact Florene Davidson seven (7) business days prior to the hearing requesting the use of the projection equipment. 1. ***CASE 15213: Application of Burnett Oil Company for a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** Burnett Oil Company seeks an order approving an 160-acre non-standard oil spacing and proration unit (project area) in the Glorieta-Yeso formation comprised of the E/2 W/2 of Section 13, Township 17 South, Range 31 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Glorieta-Yeso formation underlying the E/2 W/2 of Section 13 for all pools or formations developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the **Partition Fed. Com. Well No. 4H**, a horizontal well with a surface location in the NE/4 NW/4 of adjoining Section 24, a penetration point at an orthodox location in the SE/4 SW/4 of Section 13, and a terminus at an orthodox location in the NE/4 NW/4 of Section 13. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Burnett Oil Co., Inc. as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 9 miles east of Loco Hills, New Mexico.
2. ***CASE 15214: Application of Mewbourne Oil Company for a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico.*** Mewbourne Oil Company seeks an order approving an 160-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the E/2 E/2 of Section 1, Township 26 South, Range 31 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the E/2 E/2 of Section 1 for all pools or formations developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the **Big Sinks 1 A2PA Fed. Com. Well No. 1H**, a horizontal well with a surface location in the NE/4 NE/4 of adjoining Section 12, with the beginning of the productive interval at an orthodox location in the SE/4 SE/4 of Section 1, and a terminus at an orthodox location in the NE/4 NE/4 of Section 1. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 17 miles east-southeast of Lakewood, New Mexico.
