
Ladies & Gentlemen:

This letter is to advise you that Apache Corporation and COG Operating LLC have filed the enclosed application with the New Mexico Oil Conservation Division seeking amendments to the special rules and regulations for the following pools: the Artesia Glorieta-Yeso Pool, the Bear Grass Draw Glorieta-Yeso Pool, the Empire Glorieta-Yeso Pool, the East Empire Glorieta-Yeso Pool, the Grayburg Jackson Yeso Pool, the North Leamex Paddock Pool, the West Maljamar Yeso Pool, the Cedar Lake Glorieta-Yeso Pool, the Fren-Glorieta Yeso Pool, the East Fren Glorieta Yeso Pool, and the Loco Hills Glorieta-Yeso Pool. The new rules and regulations would increase the depth bracket allowable from 300 barrels to 600 barrels of oil per day and make permanent the Temporary Special Rules previously set forth by the Division for these pools.

This application has been set for hearing before a Division Examiner at 8:15 a.m. on Thursday, September 18, 2014. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Pre-hearing Statement four days in advance of a scheduled hearing. This statement must be filed at the Division's Santa Fe office at the above specified address and should include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the attorney will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.

Apache Corporation ("Apache") and COG Operating LLC, hereby make application for an order amending Temporary Special Pool Rules No. 2 for eleven Glorieta-Yeso pools established by Order No. R-13382-E and to make the amended Rules permanent, and in support thereof, state as follows:

2. The development and spacing of these pools are governed by the Division's Order No. R-13382-E which established the following Temporary Special Pool Rules:

**Rule 1:** Any well completed in the Glorieta-Yeso formations within the horizontal boundaries of these Glorieta-Yeso oil pools, or within one mile of the outer boundaries of said pools, and not within, or closer to, another Glorieta- Yeso pool, shall be governed by these special rules.

**Rule 2:** The allowable for the Glorieta- Yeso production from units dedicated to wells described in Rule 1 shall be 300 barrels of oil per day, per standard 40- acre spacing and proration unit. This rule shall be effective retroactively from the date of first production of the first well completed in the Glorieta- Yeso formations in each unit.



**Rule 3:** A producing gas-oil ratio of 3000 standard cubic feet of gas per barrel of oil is applicable to these Glorieta-Yeso Pools. Any unit in the Glorieta-Yeso Pools which is producing at a gas-oil ratio greater than 3000 standard cubic feet of gas per barrel of oil and is capable of producing more than 300 barrels of oil per day or 900 MCFPD shall have its daily oil allowable reduced by 300 multiplied by a fraction, the numerator of which is 3,000, and the denominator of which is its producing gas-oil ratio.

**Rule 4:** No more than four wells shall be drilled on a 40-acre spacing and proration unit. Nothing in these rules shall prohibit an operator from drilling one or two wells per 40-acre spacing and proration unit as long as the maximum of four wells per 40-acre spacing and proration unit is not exceeded.

**Rule 5:** Operators may make up or balance overproduction and underproduction of oil from each unit in a calendar year; and any unit on which a new well is completed during a year shall combine that year with the following year for balancing over and underproduction. Each Operator shall calculate and report the over or underproduced status of each unit it operates in compliance with these Rules, and file a report with the Division no later than each March 1 of the preceding year, showing the over or underproduced status of each unit it operates as of the previous December 31.

**Rule 6:** In all other respects, the wells in these Glorieta-Yes Pools shall remain subject to statewide rules.

3. Under the terms of Order No. R-13382-E the temporary special rules are set to expire on September 1, 2014.

4. Apache and COG are operators in the pools. Since the entry of Order No. R-13382-E, experience has shown that the depth bracket allowable of 300 barrels per day established by Special Rule No. 2 is insufficient to allow wells to be produced at their maximum efficient rate. Increasing the allowable to 600 barrels per day will prevent waste, will facilitate maximum ultimate recovery of the reservoir and efficient maintenance of producing facilities, and will not damage the reservoir. (MER)

5. Apache and COG therefore request that the Division reopen Case No. 14613 to amend the temporary special rules as follows:

(a) The Division amends its Order No. R-13382-E Special Rule No. 2 to increase the allowable for the Glorieta-Yeso production from units dedicated to wells described from 300 to 600 barrels of oil per day, per standard 40- acre spacing and proration unit.

(b) The Temporary Special Rules should be made permanent.

6. The granting of this application is in the interests of conservation, the prevention of waste and the protection of correlative rights.

7. Notice of this application will be given to all division-designated operators in the pool and division-designated operators of wells within the same formation as the pool within one mile of the pool's outer boundary as shown on Exhibit A in accordance with the Division's rules.

WHEREFORE, Apache Corporation and COG Operating LLC request that this application be set for hearing before an Examiner of the Oil Conservation Division on September 18, 2014, that notice be given as required by law and the rules of the Division, and that the application be approved.
