2 EXAMINER GOETZE: Good morning, ladies and
3 gentlemen. Today is October 2nd, 2014. This is the Oil
4 Conservation Division Examiner Hearing, Docket Number
5 30-14, and it's being heard in Porter Hall, Santa Fe.
6 Currently, I, Phillip Goetze, will be your Hearing
7 Examiner for half of the cases. Certain cases have been
8 reserved for Mr. Scott Dawson, who will be hearing Cases
9 15210, 15211 and 15212.

10 As far as changes to the docket, Case 15205
11 has been continued to October 16th. All the other cases
12 remain on the docket.

13 Are there other changes or additions?

14 Very good. At this time --

15 MS. FELDEWERT: Mr. Examiner, it's my
16 understanding that there was a notice provided yesterday
17 by the attorney for the last case, 15192.

18 EXAMINER GOETZE: BOPCO?

19 MS. FELDEWERT: Yes.

20 EXAMINER GOETZE: Who is representing that?

21 MS. FELDEWERT: It was Gary Larson.

22 EXAMINER GOETZE: Gary Larson? Okay.

23 MR. FELDEWERT: He had contacted us about a
24 continuance. We had concurred, and he had e-mailed the
25 Division about continuing the matter to October 31st.

1 EXAMINER GOETZE: Very well then. Case
2 15192 will be continued to October 31st. And thank you.

3 At this time I will yield to Secretary
4 Martin, who has several announcements to be made.

5 Secretary Martin.

6 SECRETARY MARTIN: I read the proceedings
7 from the hearing last week. I have some issues with
8 what I read. And if you were here last week and heard
9 any introductory remarks that you feel pertain to
10 policy, I want you to disregard those. We are in the
11 process of reviewing the policy for hearings. We're
12 going try to expedite hearings. We want to have more
13 interaction with the applicants early on so that we
14 don't, when the hearing starts, bring in a lot of new
15 information. We want to try to work things out as best
16 we can beforehand. We have a meeting this afternoon to
17 discuss this policy. It will come out in writing.

18 If any of you have any thoughts or concerns
19 in this regard that you want to get your input on, I
20 suggest you get it in very quickly because we're going
21 to change this policy very soon. So thanks for your
22 attendance.

23 EXAMINER GOETZE: With that, we will go
24 back to the docket.


