### VERIFIED STATEMENT OF PAUL HADEN

Paul Haden, being duly sworn upon his oath, deposes and states:

1. I am a landman for Mewbourne Oil Company ("Mewbourne"), and have personal knowledge of the matters stated herein.

2. Pursuant to NMAC 19.15:4.12.A(1), the following information is submitted in support of the compulsory pooling application filed herein:

(a) The purpose of this application is to force pool a record title owner in a federal oil and gas lease for purposes of obtaining Bureau of Land Management ("BLM") approval of a communitization agreement.

(b) No opposition is expected because the record title owner being pooled is deceased, and his heir has been contacted regarding the proposed well but refuses to sign the communitization agreement.

(c) A plat outlining the unit being pooled is attached hereto as Attachment A. Mewbourne Oil Company seeks an order approving a 160-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the S/2N/2 of Section 27, Township 18 South, Range 30 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the S/2N/2 of Section 27 to form a non-standard 160 acre oil spacing and proration unit (project area) for all pools or formations developed on 40 acre spacing within that vertical extent. The unit is to be dedicated to the Ursa 27 B2EH Fed. Com. Well No. 1H, a horizontal well with a surface location in the SW/4NW/4, and a terminus in the SE/4NE/4, of Section 27.

(d) The party being pooled is B.N. Muncy, Jr., who owns a 50% record title interest in Lease LC 058186. A copy of the BLM's Serial Register Page for the lease, which covers the SE/4NE/4 of Section 27, is attached hereto as Attachment B.

(e) A copy of the proposal letter sent to the record title owner's heir is attached hereto as Attachment C. This address on the letter is current and correct In addition, we have spoken with Nelson Muncy regarding signing communitization agreements for this well and other wells drilled by Mewbourne.

(f) Mewbourne has made a good faith effort to obtain the voluntary joinder of the interest owners in the communitization agreement for the well.

(g) Because the pooled party owns only record title, a risk charge is not requested.

(h) Because the pooled party owns only record title, overhead charges are not requested.

(i) The offset operators or working interest owners are listed on Attachment D.

(j) Applicant requests that it be designated operator of the well.


