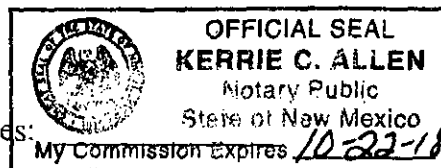


1. I am over the age of 18, and have personal knowledge of the matters stated herein.

The Pre-Hearing Statement must also be provided to the undersigned.
