Mr. Ahuja:

WPX Energy Production, LLC, ("WPX"), as an owner of an interest in the oil and gas leasehold estate in and under Section 33 - T24N-R8W, San Juan County, New Mexico, hereby proposes to drill the Chaco 2408-33D #113H Well as a horizontal well to a depth sufficient to test the Mancos formation. As the attached plat demonstrates, WPX plans to utilize a surface location approximately 1304' FNL and 372' FWL of Section 33 in Unit D, enter the formation in Unit H of Section 33, and then proceed horizontally to the east with the terminus of the wellbore located approximately at 2420' FNL, and 230' FEL in Unit H of Section 33. A 320 acre project area consisting of the N/2 of Section 33 will be dedicated to this well. Please realize that minor discrepancies in the location of the bottom hole as outlined in this proposal and reflected on the provided plat are possible.

According to the title information now available for these sections, you own a 100% WI in the NW/4 of Section 33-T24N-8W, giving you a 50% WI in this well. As set forth in the attached AFE, the estimated dry hole cost for the Chaco 2408-33D #113H Well is \$2,105,468 with an estimated completion cost of \$3,378,200. This results in an estimated completed well cost of \$5,483,668.
