APPLICATION OF DEVON ENERGY PRODUCTION COMPANY, L.P. FOR A NON-STANDARD OIL SPACING AND PRORATION UNIT AND COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

<u>APPLICATION</u>

Devon Energy Production Company, L.P. applies for an order (i) approving a nonstandard oil spacing and proration unit in the Bone Spring formation comprised of the N½S½ of Section 10, Township 19 South, Range 31 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and in support thereof, states:

1. Applicant is an interest owner in the N½S½ of Section 10, and has the right to drill a well thereon.

2. Applicant proposes to drill its Hadar 10 Fed. Com. Well No. 3H to a depth sufficient to test the Bone Spring formation, and seeks to dedicate the $N\frac{1}{2}S\frac{1}{2}$ of Section 10 to the well to form a non-standard 160 acre oil spacing and proration unit (project area) for any formations and/or pools developed on 40 acre spacing within that vertical extent. The well will be a horizontal well, with a surface location 2155 feet from the south line and 5 feet from the west line, and a terminus 1980 feet from the south line and 340 feet from the east line, of Section 10. The producing interval will be orthodox.

3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the $N\frac{1}{2}S\frac{1}{2}$ of Section 10 for the purposes set forth herein.

4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners underlying the N½S½ of Section 10, as set forth above, pursuant to NMSA 1978 §§70-2-17, 18.

5. Approval of the non-standard unit and the pooling of all mineral interests underlying the $N\frac{1}{2}S\frac{1}{2}$ of Section 10 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

A. Approving a non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the N½S½ of Section 10;

B. Pooling all mineral interests in the Bone Spring formation underlying the N½S½ of Section 10;

C. Designating applicant as operator of the well;

D. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;

E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

F. Setting a 200% charge for the risk involved in drilling and completing the well in
the event a working interest owner elects not to participate in the well.
