**APPLICANT'S STATEMENT OF CASE**

COG Operating LLC seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the E/2 E/2 of Section 16, Township 18 South, Range 30 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation (Loco Hills; Bone Spring East pool (39513)). This proposed non-standard spacing and proration unit will be the project area for the **Cookie Tosser State Com No. 1H Well**, which will be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 9 to a

standard bottom hole location in the SE/4 SE/4 (Unit P) of Section 16. The completed interval for this well will comply with the Division's setback requirements.
