
AMENDED APPLICATION

Nacogdoches Oil and Gas, Inc. applies for an order approving a water disposal well, and in support thereof, states:

1. Applicant proposes to convert to disposal the South Hospah Unit Well No. 9, located 330 feet from the north line and 2051 feet from the east line of Section 12, Township 17 North, Range 9 West, N.M.P.M., McKinley County, New Mexico.
2. A Form C-108 for the South Hospah Unit Well No. 9, to be re-named the South Hospah SWD Well No. 9, was previously submitted to the Division. Injection will be into the Entrada formation at a depth of 3794-3854 feet subsurface.
3. Applicant further requests an exception to Division Rules NMAC 19.15.5.9 and 19.15.26.8 to allow it to convert the subject well to disposal even though it has not satisfied Division compliance rules.
4. The granting of this application will prevent waste and protect correlative rights.

**WHEREFORE**, applicant requests that, after notice and hearing, the Division enter its order approving the application.
