STATEMENT OF THE CASE

Applicant, Mesquite SWD, Inc. ("Mesquite") seeks an order to (i) drill its proposed Johnny East SWD Well No. 1, to be located 300 feet from the south line and 2340 feet from the west line of Section 11, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico; (ii) to dispose of produced water into the Basal Yates and Upper Seven Rivers formations at depths of 3378-3388 feet subsurface.

Fulfer and Driftwood oppose Mesquite's application for a salt water disposal well. Fulfer operates producing wells that are producing or capable of producing hydrocarbon reserves in close proximity to the proposed disposal well which will be adversely affected. In addition, the proposed disposal well would be located within the Capitan Reef Complex.
