<u>APPLICATION</u>

Matador Production Company ("Matador"), OGRID Number 228937, through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of NMSA 1978, Section 70-2-17, for an order: (1) creating a non-standard 320-acre, more or less, gas spacing and proration unit in the Wolfcamp formation, comprised of the S/2 of Section 13, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico; (2) pooling all mineral interests in the Wolfcamp formation underlying this proposed non-standard spacing and proration unit; and (3) approval of a non-standard location. In support of this application, Matador states as follows:

- 1. Matador is an interest owner in the subject lands and has the right to drill a well thereon.
- 2. Matador seeks to dedicate the S/2 of Section 13 to the proposed well to form a non-standard 320-acre, more or less, gas spacing and proration unit (the "project area").

- 3. Matador proposes to drill the Janie Conner 13-24S-28E RB #224H well, API Number 30-015-43037, to a depth sufficient to test the Wolfcamp formation. This well is a horizontal well with a surface location 445 feet from the South line, 255 feet from the East line (Section 14), and a terminus 331 feet from the South line, 240 feet from the East line (Section 13).
- 4. Matador seeks to drill the Janie Conner 13-24S-28E RB #224H well in an unorthodox location that does not comply with the setback requirements. This project area is within the Pierce Crossing, Wolfcamp NW Gas pool (pool code 96712). This pool is governed by rule 19.15.15.10(B), requiring an initial well on a 320-acre unit that is located no closer than 660 feet to the outer boundary of the quarter section on which the well is located. In addition for horizontal wells, every point of the completed interval must meet the minimum setback requirement from the outer boundaries of the project area. 19.15.16.15(B)(2). The completed interval for the Janie Conner 13-24S-28E RB #224H is as follows:
 - a. <u>Beginning of Producing Interval</u>: 330 feet from the South line and 330 feet from the West line of Section 13;
 - b. End of Producing Interval: 331 feet from the South line and 330 feet from the East line of Section 13.
- 5. Included in Exhibit A is the list of persons who are entitled to notice of the non-standard location under Subsection A of 19.15.4.12 NMCA. Copies of this application, including all attachments, have been mailed to each affected person via certified mail-return receipt requested, pursuant to Division Rules.
- 6. Matador sought, but has been unable to obtain a voluntary agreement from all interest owners in the Wolfcamp formation underlying the proposed project area to participate in the drilling of the well or to otherwise commit their interests to the well.

- 7. Approval of the non-standard unit, non-standard location, and the pooling of all interests in the Wolfcamp formation underlying the proposed project area will prevent the drilling of unnecessary wells, prevent waste and protect correlative rights.
- 8. Notice of this application has been given in accordance with Division rules as shown on Exhibit A.

WHEREFORE, Matador Production Company requests this application be set for hearing before an Examiner of the Oil Conservation Division on May 28, 2014, and after notice and hearing as required by law, the Division enter its order.

- A. Creating a non-standard oil spacing and proration unit ("project area") in the Wolfcamp formation comprised of S/2 of Section 13, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico;
- B. Pooling all mineral interests in the Wolfcamp formation underlying this non-standard spacing and proration unit/project area;
 - C. Approval of a non-standard location;
- D. Designating Matador as operator of this unit and the well to be drilled thereon;
- E. Authorizing Matador to recover its costs of drilling, equipping and completing this well;
- F. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- G. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.
