In these two cases, COG Operating LLC seeks an order (1) creating two 160-acre spacing and proration units comprised of the E/2 W/2 and W/2 W/2 of Section 10, Township 24 South, Range 34 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage. The E/2 W/2 non-standard spacing and proration unit will be the project area for the proposed **Salvador Fee No. 3H Well,** which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) to a standard bottom hole

location in the NE/4 NW/4 (Unit C) of Section 10.
