

This letter is to advise you that COG Operating LLC has filed the enclosed application with the New Mexico Oil Conservation Division. Your interests are not being pooled under this application. You are receiving notice of this application because you own an interest below 4,000' in the Yeso formation (Red Lake; Glorieta Yeso Northeast pool) that is not being pooled for the proposed well. The pooled interval for the proposed well is limited to that portion of the Yeso formation above 4,000'.

This application has been set for hearing before a Division Examiner at 8:15 AM on May 14, 2015. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. 
