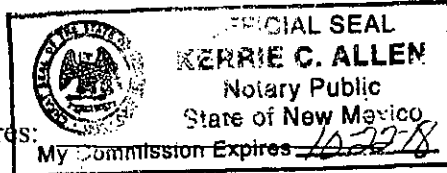


Ladies and gentlemen:
