STATEMENT OF THE CASE

WPX seeks an order authorizing an unorthodox well location for its **NE Chaco Com**Well No. 255H (API No. 30-039-31291), a horizontal well drilled within the Northeast Chaco
Horizontal Well Project Area approved under Division Order R-13817. This area is subject to the

Northeast Chaco Unit HZ Oil Pool (Pool Code 98088) created under Division Order R-13817-A which requires the completed interval to be at least 330 feet from the outer boundary of the Project Area. The subject well has been drilled from a surface location 1305 from the south line and 240 feet from the west line of Section 5 to a bottom hole location 325 feet from the north line and 231 feet from the east line of Section 8 in Township 23 North, Range 6 West, NMPM. The completed interval for this well was mistakenly perforated in Unit A of Section 8 at a point 293 feet from the eastern boundary of the Northeast Chaco Horizontal Well Project Area, thereby encroaching on the spacing unit to the east by 37 feet.
