STATEMENT OF THE CASE

APPLICANT

Mewbourne Oil Company seeks an order approving a 160-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the E/2E/2 of Section 9, Township 23 South, Range 34 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the E/2E/2 of Section 9 for all pools or formations developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the Antelope 9 B3PA State Well No. 1H, a horizontal well with a surface location in the SE/4SE/4, and a terminus in the NE/4NE/4, of Section 9.
