
THE FEDERAL AND STATE GOVERNMENT WITH ENERGY AND MINERALS,

HAVE OFFERED TO CYRQ AND THEY SEEM VERY INTERESTED, THE
INJECTION WELL IS IN THE COOLING ACQUIFER (SEE MANY SHALLOW
GRADIENT MAPS) THAT HAVE NATURALLY COOLED THE GEOTHERMAL IN
WATER ACQUIFERS FOR MILLIONS OF YEARS, THIS WOULD STOP FUTURE
PROBLEMS OF ANY COMINGLING, DEGRADING OF THE HOT GEOTHERMAL
FIELD LEAVING NOTHING BUT THE HIGHEST QUALITY HEAT FOR USERS.
THE FLOW CHART OF THE GEOTHERMAL WATERS--MAKE
ELECTRICITY>GREENHOUSES OR OTHER LOWER HEAT USERS>WET
LANDS>WATER FOR NATIVE VEGETATION AND /OR INJECTION-100%
BENIFICIALUSAGE.

IN THE BIG PICTURE ALL THE GEOTHERMAL WATER THAT LIGHTING
DOCK CAN PRODUCE NEEDS TO USED FOR BENIFICAL USE, NOT
DEGRADED BY REINJECTION IN THE HOT AREA (WE ARE JUST ON THE
LEADING EDGE OF THE POTENTIAL IF WE DON'T MESS IT UP) THE
GEOTHERMAL AND THE NEED FOR ELECTRICITY AND OTHER USAGE WILL
BE THERE FOR MANY YEARS TO COME. THE HOT GEOTHERMAL WATER
WILL STILL BE AVAILABLE TO US SHALLOW USERS, CYRQ CANT CAPTURE
ALL THE FLOW FROM THE DEEP FALT IT IS COMING UP THROUGH.
