2 8:25 a.m.:

3 EXAMINER JONES: Let's call Case 13,544, which is
4 continued and readvertised, Application of XTO Energy,
5 Inc., to amend the special rules and regulations of the Ute
6 Dome-Paradox Gas Pool and to expand the horizontal limits
7 of the pool in San Juan County, New Mexico.

8 Call for appearances.

9 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,
10 representing the Applicant. I just have a brief statement.

11 Mr. Examiner, as you said, this is a case to
12 amend the special rules and regulations for the Ute Dome-
13 Paradox Gas Pool and to expand the pool. This matter was
14 previously heard by Examiner Ezeanyim.

15 The original Application asked to add Section 4
16 of Township 31 North, Range 14 West, to the pool, when in
17 fact we meant to ask that the pool be expanded to include
18 Sections 4 and 12. So after the hearing an amended
19 Application was filed and additional notice was given.

20 And I have submitted to you -- I forgot to mark
21 the exhibit number, if you could mark that Exhibit A.

22 EXAMINER JONES: Okay.

23 MR. BRUCE: It's simply the notice that was given
24 pursuant to Division Rules to the offset oper- -- the only
25 operators in the pool, other than XTO Energy. Notice was

1 also -- this was also primarily Ute Mountain Ute Indian
2 land, so notice was given to the Tribe and its
3 representatives. And you should have, if not received,
4 another letter from the Tribe stating that they support the
5 Application.

6 Thank you.

7 EXAMINER JONES: Okay, thank you, Mr. Bruce.
8 With that, we'll take Case 13,557 under advisement.
