AND LEA COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on October 20, 2005, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 27<sup>th</sup> day of October, 2005, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Devonian formation, bearing the designation of North Burtner-Devonian Pool (**Pool Code 97455**). The North Burtner-Devonian Pool was discovered by the Energen Resources Corporation Saunders Deep State Well No. 1 (**API No. 30-025-36859**) located in Unit A of Section 3, Township 15 South, Range 33 East, NMPM, which was completed in the Devonian formation on May 24, 2005. The top of the perforations is at 13,542 feet.

(3) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Atoka formation, bearing the designation of South Button Mesa-Atoka Gas Pool (**Pool Code 97462**). The South Button Mesa-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Faron State Unit Well No. 1

(API No. 30-025-37075) located in Unit B of Section 5, Township 9 South, Range 32 East, NMPM, which was completed in the Atoka formation on June 11, 2005. The top of the perforations is at 10,577 feet.

(4) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Atoka formation, bearing the designation of West Caprock-Atoka Gas Pool (**Pool Code 97460**). The West Caprock-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Patsy State Unit Well No. 2 (**API No. 30-005-27934**) located in Unit M of Section 11, Township 12 South, Range 31 East, NMPM, which was completed in the Atoka formation on June 24, 2005. The top of the perforations is at 10,722 feet.

(5) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Strawn formation, bearing the designation of Dempster Mill-Strawn Gas Pool (**Pool Code 97471**). The Dempster Mill-Strawn Gas Pool was discovered by the Yates Petroleum Corporation Dempster Mill Unit Well No. 2 (**API No. 30-025-36785**) located in Unit L of Section 31, Township 11 South, Range 36 East, NMPM, which was completed in the Strawn formation on July 21, 2005. The top of the perforations is at 11,836 feet.

(6) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Grayburg formation, bearing the designation of West Hume-Grayburg Pool (**Pool Code 97444**). The West Hume-Grayburg Pool was discovered by the Mack Energy Corporation Snapper State Well No. 1 (**API No. 30-025-37053**) located in Unit F of Section 14, Township 16 South, Range 33 East, NMPM, which was completed in the Grayburg formation on May 10, 2005. The top of the perforations is at 4,398 feet.

(7) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Atoka formation, bearing the designation of South Jenkins-Atoka Gas Pool (**Pool Code 97475**). The South Jenkins-Atoka Gas Pool was discovered by the Yates Petroleum Corporation Vince BGH Well No. 1 (**API No. 30-025-37104**) located in Unit J of Section 30, Township 9 South, Range 35 East, NMPM, which was completed in the Atoka formation on July 6, 2005. The top of the perforations is at 11,607 feet.

(8) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Morrow formation, bearing the designation of North Mescalero-Morrow Gas Pool (**Pool Code 97472**). The North Mescalero-Morrow Gas Pool was discovered by the Yates Petroleum Corporation Fender State Unit Well No. 1 (**API No. 30-025-00012**) located in Unit K of Section 9, Township 10 South, Range 32 East, NMPM, which was completed in the Morrow formation on August 4, 2005. The top of the perforations is at 11,244 feet.

(9) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Morrow formation, bearing the designation of East

Pronghorn-Morrow Gas Pool (**Pool Code 97468**). The East Pronghorn-Morrow Gas Pool was discovered by the Chesapeake Operating Inc. Gurney 3 State Well No. 1 (**API No. 30-025-37082**) located in Unit K of Section 3, Township 23 South, Range 33 East, NMPM, which was completed in the Morrow formation on June 4, 2005. The top of the perforations is at 14,679 feet.

(10) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of South Reeves-Wolfcamp Pool (**Pool Code 97467**). The South Reeves-Wolfcamp Pool was discovered by the Paladin Energy Corporation South Vacuum Unit Well No. 261 (**API No. 30-025-03134**) located in Unit M of Section 26, Township 18 South, Range 35 East, NMPM, which was completed in the Wolfcamp formation on June 8, 2005. The top of the perforations is at 9,950 feet.

(11) There is need for the contraction of the Vacuum-Abo Reef Pool (**Pool Code 61780**) in Lea County, New Mexico in order to correct nomenclature. The deleted acreage will be placed in the South Double A-Abo Pool (**Pool Code 19050**).

(12) There is need for the contraction of the vertical limits of the South Button Mesa-Pennsylvanian Pool (**Pool Code 8380**) in Lea County, New Mexico to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the South Button Mesa-Upper Pennsylvanian Pool (**Pool Code 8380**).

(13) There is need for the extension of the vertical limits of the North Mescalero-Cisco Pool (**Pool Code 45750**) in Lea County, New Mexico to include the Cisco, Canyon and Strawn formations and the redesignation of the pool as the North Mescalero-Upper Pennsylvanian Pool (**Pool Code 45750**).

(14) There is need for certain extensions to the Antelope Ridge-Bone Spring Pool, the East Bagley-Morrow Gas Pool, the South Bell Lake-Delaware Pool, the Brinninstool-Morrow Gas Pool, the South Brunson-Drinkard-Abo Pool, the Cinta Roja-Delaware Pool, the South Corbin-Morrow Gas Pool, the Dempster Mill-Atoka Gas Pool, the South Double A-Abo Pool, the Drinkard Pool, the Northwest Eight Mile Draw-Morrow Gas Pool, the EK-Yates-Seven Rivers-Queen Pool, the East Featherstone-Bone Spring Pool, the Four Lakes-Mississippian Gas Pool, the Four Lakes-Morrow Gas Pool, the Gem-Delaware Pool, the Grama Ridge-Morrow Gas Pool, the Grayburg Jackson-Seven Rivers-Queen-Grayburg-San Andres Pool, the Hardin Tank-Bone Spring Pool, the Southeast Hat Mesa-Delaware Pool, the Hat Mesa-Morrow Gas Pool, the North Hightower-Wolfcamp Pool, the Northwest Hobbs-Abo Pool, the West Hume-Queen Pool, the Southwest Jabalina-Strawn Gas Pool, the Jalmat-Tansill-Yates-Seven Rivers Gas Pool, the East Lusk-Bone Spring Pool, the North Lusk-Bone Spring Pool, the East Lusk-Morrow Gas Pool, the Maljamar-Grayburg-San Andres Pool, the Midway-Bone Spring Pool, the Osudo-Morrow Gas Pool, the South Osudo-Morrow Gas Pool, the Paddock Pool, the Pearl-Queen Pool, the Red Tank-Bone Spring Pool, the East Red Tank-Bone Spring Pool, the Sand Springs-Abo Pool, the Sand Springs-Atoka-Morrow Gas Pool, the Skaggs-Drinkard Pool, the Stateline-Ellenburger Pool, the Teas-

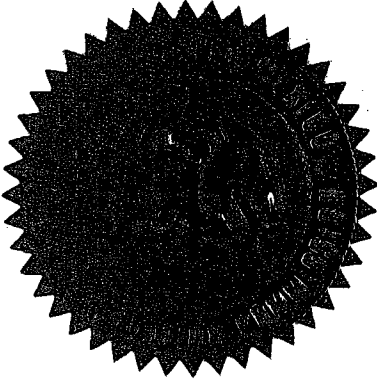
(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

---

(2) The effective date of this order and all creations, redesignations, and contractions and extensions of vertical and horizontal limits included herein shall be November 1, 2005.
