

DOCKET: EXAMINER HEARING - THURSDAY – JULY 10, 2003

Docket Nos. 22-03 and 23-03 are tentatively set for July 24, 2003 and August 7 2003. Applications for hearing must be filed at least 23 days in advance of hearing date. The following cases will be heard by an Examiner:

CASE 13047: Continued from June 5, 2003, Examiner Hearing

Application of Chesapeake Operating, Inc. for compulsory pooling, Lea County, New Mexico. Applicant seeks an order pooling all mineral interests in the Tubb formation underlying the NE/4 of Section 7, Township 20 South, Range 37E, forming a standard 160-acre gas spacing and proration unit for the Tubb formation, including but not limited to the West Monument-Tubb Gas Pool. This unit is to be dedicated to its Bertha J. Barber Well No. 12 that has been drilled and completed at an approved unorthodox well location (Order R-11652-B) in Unit A of this section. Also to be considered will be the costs of drilling and completing said well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of applicant as the operator of the well and a charge for risk involved in this well. This unit is located approximately 3 miles south-southwest of Monument, New Mexico.

CASE 13101: Application of Chesapeake Operating, Inc. for compulsory pooling, Lea County, New Mexico. Applicant seeks an order pooling all mineral interests in the Tubb formation underlying the NW/4 of Section 8, T20S, R37E, forming a standard 160-acre gas spacing and proration unit for any and all formations and/or pools spaced on 160-acre gas spacing, including but not limited to the West Monument-Tubb Gas Pool. This unit is to be dedicated to its Barber Adkins "8" Well No. 1 which is to be re-entered and tested in the Tubb formation at a standard well location in Unit D of this Section. Also to be considered will be the costs of re-entering and completing said well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of applicant as the operator of the well and a charge for risk involved in this well. This unit is located approximately 2 miles south from Monument, New Mexico.

CASE 13082: Continued from June 5, 2003, Examiner Hearing

Application of Concho Oil & Gas Corp. for compulsory pooling, Lea County, New Mexico. Applicant seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the following described acreage in Section 28, Township 19 South, Range 34 East, in the following manner: The N/2 to form a standard 320-acre gas spacing and proration unit for any formations and/or pools developed on 320-acre spacing within that vertical extent, including the Quail Ridge-Morrow Gas Pool; the NW/4 to form a standard 160-acre gas spacing and proration unit for any formations and/or pools developed on 160-acre spacing within that vertical extent, including the Undesignated Quail Ridge-Yates Gas Pool and Undesignated San Miguel-Seven Rivers Gas Pool; and the NW/4 NW/4 to form a standard 40-acre oil spacing and proration unit for any formations and/or pools developed on 40-acre spacing within that vertical extent, including the South Quail Ridge-Yates Pool, Undesignated West Pearl-Seven Rivers Pool, Undesignated Quail Ridge-Bone Springs Pool, and Undesignated South Quail Ridge-Bone Spring Pool. The units are to be dedicated to applicant's Codorniz Fed. "28" Well No. 1, to be located at an orthodox location (unorthodox in the Morrow formation) in the NW/4 NW/4 of Section 28. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a charge for the risk involved in drilling and completing the well. The units are located approximately 17½ miles west of Monument, New Mexico.
