Applicant in the above-styled cause seeks authorization to simultaneously dedicate the non-standard 160-acre gas spacing and proration unit comprised of the SE/4 SE/4 of Section 10 and the NE/4 NE/4, and the S/2 NE/4 of Section 15, Township 26 South, Range 37 East, NMPM, to its Rhodes Federal Unit Well No. 153 (API No. 30-025-31797) located in Unit A at a standard location 990 feet from the North line and 660 feet from the East line of said Section 15 and its Rhodes Federal Unit Well No. 159 which it proposes to drill at an unorthodox gas well location 2110 feet from the North line and 460 feet from the East line (Unit H) of said Section 15.


