

**CASE 13643:** *In the matter of the hearing called by the Oil Conservation Division for an order creating, extending vertical limits, redesignating and extending certain pools in Eddy County, New Mexico.*

(a) EXTEND the vertical limits of the Nash Draw-Delaware Pool (**Pool Code 47545**) in Eddy County, New Mexico to include the top of the Lamar of the Delaware Mountain Group and continue down to the base of the Avalon sands in the Upper Bone Spring formation as in Type Log Bass Enterprises Production Company Poker Lake Unit Well No. 192 (**API No. 30-015-33362**) located in Unit L of Section 8, Township 24 South, Range 30 East, NMPM. Also, redesignate the pool as the Nash Draw-Delaware/Bone Spring (Avalon Sand) Pool.

(b) CREATE a new pool in Eddy County, New Mexico classified as an oil pool for Bone Spring production and designated as the Paduca-Bone Spring Pool (**Pool Code 96641**). The discovery well is the Devon Oil Company Cotton Draw Unit Well No. 81 (**API No. 30-015-29345**) located in Unit L of Section 2, Township 25 South, Range 31 East, NMPM. Said pool would comprise:
