In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon its own motion for an order for the creation, discovery allowable assignment and extension of certain existing pools in Chaves and Eddy County, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof, to show cause why such creation, discovery allowable assignment, and extensions and or deletions should not be made.

(A) Re-designate the Nash Draw; Delaware Oil Pool as the Nash Draw; Delaware/Bone Spring (Avalon Sand) Oil Pool. The vertical limits of said pool to include the top of the Lamar of the Delaware Mountain Group and continue down to the base of the Avalon sands in the Upper Bone Spring formation. A type log that defines the vertical base of the Avalon sands in the Upper Bone Spring formation is Bass Enterprises Production Company: Poker Lake Unit # 192. Said well is located in Section 8, Township 24 South Range 30 East, in Unit L. API # 30-015-33362. The measured vertical depth of the base of the Avalon sands is-7438’.

(B) Create a new pool in Eddy County classified as an oil pool and designated as the Paduca; Bone Spring Oil Pool (**Pool Code 96641**). The discovery well , the Cotton Draw Unit # 81 (**API # 30-015-29345**) completed be Devon Oil Company, is located in Unit L, of Section 2, Township 25 South, Range 31 East, NMPM
