

APPLICATION

Pecos Production Company applies for an order creating the East Dean-Wolfcamp Pool, and instituting special rules and regulations therefor, and in support thereof, states:

1. Applicant is operator of the Overland Well No. 1 (the "Well") in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ (Unit V) of irregular Section 2, Township 16 South, Range 37 East, N.M.P.M. The Well is located at an unorthodox oil well location 1276 feet from the south line and 1724 feet from the west line of the section, which was approved by Division Administrative Order NSL-4861.

2. The Well has been completed in the Wolfcamp formation.

3. Applicant requests that the East Dean-Wolfcamp Pool be created, to initially include the SW $\frac{1}{4}$ of Section 2.

4. Applicant also requests that special pool rules be instituted for the East Dean-Wolfcamp Pool, providing for:

(a) 80 acre spacing; and

(b) all other rules to comply with statewide rules.

5. Applicant requests that the pool rules be instituted effective as of the date of first Wolfcamp production from the Well.

6. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing,
the relief requested above be granted.
