APPLICATION

Pursuant to Rule 303 C of the Rules and Regulations of the State of New Mexico Oil Conservation Division, The Applicant, Jerome P. McHugh, by and through its attorney, Tommy Roberts, hereby submits its application for approval of downhole commingling in the well bore of the Wright Way #1 Well in Rio Arriba County, New Mexico.

The Applicant further states:

1. The Operator of the Wright Way #1 Well will be the Applicant, Jerome P. McHugh, whose address is P.O. Box 208, Farmington, NM 87499.
2. The Wright Way #1 Well is situated on a fee lease at the following legal location:

Section 2: Unit Letter C
950' FNL and 1680' FWL
Rio Arriba County, New Mexico

3. The following proration units are applicable to the oil/gas pools which are the subject of this application:

Township 24 North, Range 2 West, NMPM
Section 2: NE/4 NW/4 (Undesignated Gallup)
Section 2: N/2 (Basin Dakota)

4. The Wright Way #1 Well is not currently dually completed in the Undesignated Gallup Pool and the Basin Dakota Pool.
5. The Wright Way #1 Well is capable of only low marginal production from the Undesignated Gallup Pool, and is capable of only low marginal production from the Basin Dakota Pool.
6. The ownership of the above mentioned Pools is not common.
7. The proposed commingling from the above Pools will result in recovery of additional hydrocarbons, the prevention of waste and the protection of correlative rights.

8. All operators of leases offsetting the dedicated acreage for this well, the Bureau of Land Management and the Supervisor of the District III Office of the New Mexico Oil Conservation Division have been mailed a copy of this Application.

WHEREFORE, the Applicant requests this Application be set for hearing on September 28, 1983, and that after said hearing the New Mexico Oil Conservation Division grant this Application by giving approval to the downhole commingling of the E.T. #1 Well in Rio Arriba County, New Mexico.
