

A P P L I C A T I O N

Comes now, Joe E. Brown, by and through his attorneys, Kellahin & Kellahin, and applies to the New Mexico Oil Conservation Division for approval of nine unorthodox oil well locations, Roosevelt County, New Mexico, and in support thereof would show:

1. Applicant is the operator of certain oil wells all located in Section 28, Township 7 South, Range 33 East, NMPM, Roosevelt County, New Mexico.
2. Applicant desires to drill nine additional oil wells all within Section 28, T7S, R33E, each at an unorthodox location as follows:

2630 FNL and 1310 FWL (SW/4NW/4)


5. Farrell Federal Well No. 21
2630 FSL and 1310 FEL (NE/4SE/4)
6. Farrell Federal Well No. 22
2630 FSL and 2630 FWL (NE/4SW/4)
7. Farrell Federal Well No. 23
1310 FSL and 1310 FWL (SW/4SW/4)
8. Farrell Federal Well No. 24
1310 FSL and 2630 FWL (SE/4SW/4)
9. Farrell Federal Well No. 25
1310 FSL and 1330 FEL (SW/4SE/4)

3. That the subject wells are all 40-acre spaced oil wells to be drilled to a depth of approximately 4,450 feet to test the San Andres formations.

4. That approval of this application will be in the best interests of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, applicant requests that this matter be set for hearing and that after notice and hearing the application be granted.
