APPLICATION OF JOE E. BROWN FOR
NINE UNORTHODOX OIL WELL LOCATIONS,
ROOSEVELT COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on October 12,
1983, at Santa Fe, New Mexico, before Examiner Richard L.
Stamets.

NOW, on this _____ day of October, 1983, the Division
Director, having considered the testimony, the record, and the

recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Joe E. Brown, seeks approval of nine unorthodox oil well locations to be drilled on the Farrell Federal Lease, all in Section 28, Township 7 South, Range 33 East, *Chaveroo-San Andres Pool,* NMPM, Roosevelt County, New Mexico, as follows:

Well No. 17, 1310' FNL and 1310' FEL;

Well No. 18, 1310' FNL and 2630' FEL;

Well No. 19, 1310' FNL and 1330' FWL;

Well No. 20, 2630' FNL and 1310' FWL;

Well No. 21, 2630' FSL and 1310' FEL;

Well No. 22, 2630' FSL and 2630' FWL;

Well No. 23, 1310' FSL and 1310' FWL;

Well No. 24, 1310' FSL and 2630' FWL; and

Well No. 25, 1310' FSL and 1330' FEL.

(3) That the *quarter-quarter section wherein any of*
said wells is located in *is to*
such of said Section 28 ~~is to~~ be
dedicated to ~~the~~ wells.

(4) That wells at said unorthodox locations will better enable applicant to produce the oil underlying the proration units *and the applicants lease covering said section 28.*

(5) That no offset operator objected to the proposed unorthodox locations.

(6) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the oil in the ~~affected~~ *Chavero-San Andres* pool(s), will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Joe E. Brown for nine unorthodox oil well locations for the Farrell Federal Lease is hereby approved, said wells ~~being located~~ *all to be located* in Section 28, *Chavero-San Andres Pool,* Township 7 South, Range 33 East, NMPM, ¹ Roosevelt County, New Mexico ~~as follows:~~ *as follows:*

Well No. 17, 1310' FNL and 1310' FEL;

Well No. 18, 1310' FNL and 2630' FEL;

Well No. 19, 1310' FNL and 1330' FWL;

Well No. 20, 2630' FNL and 1310' FWL;

Well No. 21, 2630' FSL and 1310' FEL;

Well No. 22, 2630' FSL and 2630' FWL;

Well No. 23, 1310' FSL and 1310' FWL;

Well No. 24, 1310' FSL and 2630' FWL; and

Well No. 25, 1310' FSL and 1330' FEL.

(2) That the *quarter-quarter section wherein any of said wells is located in* ~~of~~ said Section 28 ~~is to be~~ *shall* be dedicated to ~~the~~ *such* wells.

(3) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
