STATEMENT OF THE CASE

APPLICANT

Burnett Oil Co., Inc. seeks an order approving a 120-acre non-standard oil spacing and proration unit (project area) in the Glorieta-Yeso formation (Fren Glorieta-Yeso Pool) comprised of the NW/4NE/4 and N/2NW/4 of Section 12, Township 17 South, Range 31 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Glorieta-Yeso formation underlying the

NW/4NE/4 and N/2NW/4 of Section 12 for all pools developed on 40 acre spacing within that vertical extent. The unit will be dedicated to the Nosler 12 Fed. DB Well No. 4H, a horizontal well with a surface location in the NE/4NE/4 of adjoining Section 11, a first take point at an orthodox location in the NW/4NW4 of Section 12, and a terminus at an orthodox location in the NW/4NE4 of Section 12. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.




