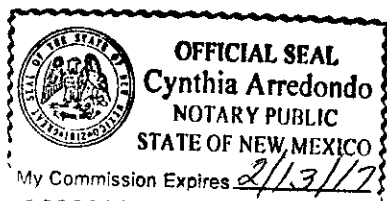

Applicant in the above-styled cause seeks an order (1) creating a non-standard, 160-acre, more or less, spacing and proration unit comprised of the W/2 W/2 of Section 11, Township 20 South, Range 25 East, NMPM, Eddy County and (2) pooling all mineral interests in the Yeso formation underlying this acreage. Said non-standard unit is to be dedicated to applicant's proposed Bone Yard 11 Fee No. 11H Well, which will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M), to a standard bottom hole location in the NW/4 NW/4 (Unit D) of Section 11. The completed interval for this well will remain within the 330-foot standard offset required by the rules. 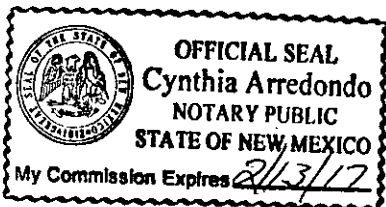
