Dear Interest Owner:

COG Operating LLC ("COG") plans to spud the Bone Yard 11 Fee #11H horizontal Yeso well in the second quarter of 2016, and spud the Bone Yard 11 Fee #12H on or before November 1, 2015. To allocate production for payment of revenue for these wells, COG is required to file a Designation of Unit for each well to pool the interests within the spacing unit of each well.

COG must obtain your approval, as a non-participating royalty interest (NPRI) owner, to pool your interest. We request that you ratify the Designation of Unit for each well and that you ratify the leases covering the mineral interests that are subject to your NPRI.

- Copies of the leases described in the Ratification of Oil, Gas and Mineral Lease.



For the Ratifications to be binding upon this interest, if you are signing as an individual, it is necessary to show the property is separate property or to have it signed by your spouse. If you are signing as an individual, please provide evidence that this is your separate property, or if this is community property, please have your spouse sign in addition to your signature.

COG will apply to the New Mexico Oil Conservation Division for compulsory pooling for both of the proposed wells. If we do not reach an agreement within 30 days of the date of this letter, your interest will be named in both of the applications.
