



Case No. 15322 De Novo: Application of Key Energy Services, LLC for approval of a salt water disposal well, Eddy County, New Mexico. Applicant seeks an order approving the disposal of produced water into the Brushy Canyon formation of the Delaware Mountain group at depths of 4082-5200 feet subsurface in the **Grace Carlsbad No. 1 well**, which is located 1980 feet from the south line and 660 feet from the east line of Section 36, Township 22 South, Range 26 East, NMPM. The well is located approximately 4 miles south of Carlsbad, New Mexico. Upon application of Key Energy Services, LLC, this case will be heard De Novo pursuant to the provisions of Division Rule 19.15.4.23 NMAC.
