## AFFIDAVIT OF D. PAUL HADEN

- D. Paul Haden, being duly sworn upon his oath, deposes and states:
- 1. I am a landman for Mewbourne Oil Company ("Mewbourne"), and have personal knowledge of the matters stated herein.
- 2. I have previously testified before the Division, and my qualifications as an expert petroleum landman were accepted of record.
- 3. I have been involved in this prospect for approximately five years, and I am familiar with the land matters involved in this application.
- 4. All of Section 15, Township 18 South, Range 30 East, N.M.P.M. is federal land (surface and minerals). The W/2SW/4 of Section 15 is unleased federal minerals.
- 5. I have been in touch with the Bureau of Land Management ("BLM") since February 2011, seeking to have the BLM lease the W/2SW/4 of Section 15. E-mails regarding this effort are attached hereto as Exhibit A. The BLM has consistently refused to lease the W/2SW/4 of Section 15, because the BLM deems the surface to be in an environmentally sensitive area, and it is conducting a habitat evaluation in the area including Section 15.
- 6. As a result, the BLM has restricted the area in which wells in Section 15 could have surface locations.
- 7. On September 3, 2014, Mewbourne personnel (including myself) met with Jim Rutley and Ed Fernandez of the BLM in Carlsbad. The BLM required Mewbourne to present a plan of development for Section 15 before it would approve Mewbourne's initial APD in Section 15, for the Leo 15 DA Fed. Com. Well No. 1H.

8. Mewbourne presented a plan of development for four wells in Section 15, and the BLM requested that Mewbourne form a 560 acre project area in Section 15 (all of the section except for the unleased W/2SW/4 of Section 15), and communitize that acreage. It also required that all wells in Section 15 have surface locations in the NW/4NW/4 of Section 15, due to the habitat evaluation. Mewbourne has complied with the BLM's requests.

Mr. Rutley , the captioned lease covering the E/2NE/4 , SW/4NE/4 ,SE/4NW/4 , SE/4SW/4 and SW/4SE/4 of Sec. 22 , T18S, R30E , Eddy Co. dated 2-1-55 was suspended 9-1-59 due to potash. to the lease if it could be placed up for sale. Mewbourne owns leasehold within the Section and wants to drill some horizontal Bone Spring


oil wells. I would appreciate it if you could check on the status of the BLM's study regarding this acreage. My last conversation with you was
