**APPLICANT'S STATEMENT OF CASE**

COG Operating LLC seeks an order (1) creating a 318.64-acre, more or less, spacing and proration unit comprised of the W/2 W/2 of Section 32, Township 20 South, Range 34 East, and Lots 1, 8, 9, and 16, Section 5, Township 21 South, Range 33 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation. Said non-standard unit is to be dedicated to applicant's proposed **Goose State Com No. 2H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 32 to a

standard bottom hole location in the SW/4 SW/4 (Lot 16) of Section 5. The completed interval for this well will comply with the Division's setback requirements.


