Dear Director David Catanach:

I am writing this letter to protest the application for the aforementioned Brine Water Disposal which High Roller Wells LLC is proposing near my property. My property is 2 lots South of the proposed site, within just a few hundred feet.

I am extremely opposed to the Disposal request for very legitimate reasons! The safety of our neighborhoods is first and foremost. There have already been many accidents within 2 miles of this area due to the increase in oil production which in turn, caused an increase in large Semis and Tanker Trailers traveling to and from locations. Their unsafe speeds and long hauling hours make for very favorable accident conditions. Also, these drivers are not normally from our town, or neighboring cities. They come from other cities, for 5-7 days at a time, then head home for 2-3 days off. They are not always of high character. They come to make large amounts of money due to the extreme amounts of overtime they can earn, then head back to El Paso, or Houston, or other border towns. I will never feel that my kids are safe with the ridiculous amount of strangers this will bring to our immediate area! This is very terrifying! The safety of our community, our children, and our families are all of utmost importance!!

These Disposal stations run 24hrs around the clock. The traffic from the haulers will increase the noise, light and dust near my family's residences when they travel in and out of the disposal facility, day in and day out. With this well being placed in close proximity to my property and family's residences, I am greatly concerned with the impacts to air quality this well will bring. The odor from gases and hydrocarbons in the injected water and dust in the air would significantly affect our lives and health.

In addition, I am highly concerned about potential leaks and spills and runoff onto our properties. And many years down the road, underground casings will deteriorate and fail and leak. My property and my family's properties are located directly south and downhill from the proposed disposal site. As you know, produced water contains high levels of chlorides, hydrocarbons, and other contaminants that have the potential to runoff onto my property and affect my vegetation. Most of the families in this area supplement our diets with vegetables that we grow during spring

and summer. This Brine Station will eventually contaminate the area, and we worry that our vegetables will also be contaminated. My father has farmed this area for over 50 years. He farms alfalfa and cotton and his harvests are his only form of income. His farms are directly South of this site. His livelihood could be jeopardized if any form of contamination occurs, as well as that of the neighboring farmers, and future generations to come.


Even though the area is mostly a farming community, I have many family members who live in close proximity to this well (About 6 families within ½ mile). We have lived here all our lives and enjoy the solitude that we have here. If this application is approved, we will lose that solitude and peacefulness, to noise, to trucks, to non-stop traffic, to nighttime lights, and to strangers.

I do support the Oil Field and the amount of jobs it brings for our community. But I am certain that this Disposal can be relocated to a location that is away from a residential area. I am personally employed in the Oil Field industry. I manage a Water Transport Company. I am completely familiar with all the Disposals in the area and the noxious odor and all the other negative factors that accompany them. None of the other disposals have the close proximity to a very active residential/farming area. There is a vast amount of raw land in which it can be relocated to. I understand why High Roller Wells is trying to drill in this location...so that they can take advantage of the money to be made because it is closer than other disposals. Hauling companies will choose this Disposal over one that is located further out in order to save time and money. I do not blame High Roller Wells for taking advantage of the oil boom and trying to make money, but definitely not at the cost of the negative factors involved with its location.

When you are reviewing the application for this Brine Disposal please take into account the many families that will be affected by this well. In my case, it will literally be within 200 feet of my back porch and within 200 feet of my 2 and 4 year old. Please imagine what that scenario entails. Imagine the large unsightly disposal, imagine the dust, imagine the gas odors, imagine the noise, imagine the nighttime lights, and lastly imagine the Semi/tanker traffic which WILL cause accidents. All negatives...



Attention Brian Wood:

I am writing this letter to protest and highly object the Salt Water Disposal (SWD) well application, submitted by High Roller Wells, LLC. My home and land area are adjacent to this potential SWD well site, which led to my decision to submit this formal protest.

The potential SWD well is located approximately 335' due north and uphill from my property. Every time we have a good rainfall, water runoff from the proposed site floods my trees, shrubs, yard, and all the landscaping on my property. I am concerned water runoff from the proposed SWD well site will contaminate, pollute, and eventually poison our vegetation. There are several SWD sites in the surrounding areas of Malaga and beyond. Through our experience from witnessing and working around these wells, we know they tend to have incidental spills, are under pressure, and have the potential to explode or catch fire. In addition, we know along with the disposed salt water, there is potential of oil and other chemicals being carried from their extraction well to SWD well sites, similar to the proposed Gossett SWD Well. I am concerned about the safety for not only myself, but our children, animals, and livestock.

The location of the proposed SWD well is adjacent to US Highway 285, statistically one of the most dangerous highways in New Mexico (KRQE News, 2014). With the planned SWD well, an increase of traffic is most likely to accompany this project. With the adjacent curves North and South of the site, the increase of the turning water trucks & heavy equipment will present new traffic hazards to our neighborhood, of which we have already had 5 fatalities, in front of our homes on the highway in 2014.

Our family has lived in this area for over 5 generations, as farmers and oil field employees. Please note we support the productivity of the oil field to our community, however an alternative site and location for the proposed Gossett SWD 1 Well, away from our residence and our neighborhood locally known as "Vasquezville," should be considered. I would be very happy to address any issues you have with this formal protest.

NMOCD

On October 4, 2014, a legal notice was published in a Carlsbad, New Mexico newspaper, stating that a company (High Roller Wells, LLC) will apply to the NMOCD for approval of the referenced water disposal well. An excerpt of the newspaper is attached for your review. This excerpt is the only information our firm has regarding the proposed well.

That legal notice states "Disposal will be into the Bell Canyon and Cherry Canyon zones from 2,500' to 5,500' ". We believe that our firm will be affected by this application, since we are:

- A leasehold owner within the NMOCD's prescribed "½ mile radius of review", and
- An operator with active oil wells within 1 mile of the proposed well,

We formally object to the proposed water injection depth range of 2,500' to 5,500'. We also object to the applicant's proposed, maximum disposal rate of 30,000 barrels of water per day.

BK Exploration Corporation operates 8 oil wells in the adjacent Section 34. Those wells are completed in the Brushy Canyon zone of the Delaware Mountain Group. Current perforation depths in those wells range approximately from 6,000' to 6,300'. While drilling those wells, a mud logger observed additional oil and gas shows generally from 4,950' to 6,000'. Those shows occur within the stratigraphic depths included in the attached legal notice.

An oil show at 4,950', in Section 34, roughly corresponds to a stratigraphic depth of 4,850' in the applicant's Section 33. To prevent loss of potential, recoverable oil and gas reserves in our Section 34 wells, we believe that any water disposal in Section 33 should be restricted to depths above 4,800'.


Further, our firm foresees additional drilling of oil and gas wells in the Southwest Quarter of Section 34. Those wells will attempt completions in the deeper Brushy Canyon, Bone Spring and Wolfcamp zones. Two such wells are currently permitted with the NMOCD. Should the proposed disposal well be allowed to inject waters at magnitudes approaching tens of thousands of barrels per day, the likely crossflow of water into Section 34 could detrimentally affect our ability to drill those upcoming wells.

In summary, our firm's objections to the disposal well, as currently advertised, are made to:

1. Prevent waste of potentially recoverable oil and gas reserves in the Brushy Canyon zone, at depths of 4,950' to 6,300', in existing Section 34 wells; and
2. Prevent waste of known, recoverable oil and gas reserves in the Brushy Canyon, Bone Spring, and Wolfcamp zones, covering a general depth range of 4,950' to 10,500', in wells either permitted or planned in the Southwest Quarter of Section 34.

Attached is a well map that centers on the referenced Section 33, which is located south of the village of Loving, New Mexico.
