**APPLICANT'S STATEMENT OF CASE**

EOG seeks an order (1) creating a 160-acre spacing and proration unit comprised of the S/2 S/2 of Section 32, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying this acreage. EOG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Qualifier 32 State Com No. 502H Well**, which will be horizontally drilled from a surface location in the SW/4 SW/4 (Unit

M) to a standard bottom hole location in SE/4 SE/4 (Unit P) of Section 32. The completed interval for this well will commence and remain within the 330-foot standard offset required by the statewide rules.




