Mr. Ahuja:

WPX Energy Production, LLC, ("WPX"), as an owner of an interest in the oil and gas leasehold estate in and under Section 12- T23N-R8W, San Juan County, New Mexico, hereby proposes to drill the Chaco 24307-07N #409H Well as a horizontal well to a depth sufficient to test the Mancos formation. As the attached plat demonstrates, WPX plans to utilize a surface location approximately 971' FSL and 2186' FWL of Section 7-23N-R7W in Unit N, enter the formation in the NW/4 NW/4 (Unit K) of Section 7 7-23N-R7W, and then proceed horizontally to the West with the terminus of the wellbore located approximately at 2600' FSL, and 230' FWL in the NW/4 NW/4 (Unit L) of Section 12- T23N-R8W. A 240 acre project area consisting of the N/2 S/2 of Section 12- T23N-R8W and the N/2 SW/4 of Section 7 – T23N-R7W will be dedicated to this well. Please realize that minor discrepancies in the location of the bottom hole as outlined in this proposal and reflected on the provided plat are possible.

According to the title information now available for these sections, you own a 100% WI in the SW/4 of Section 7 – T23N-R7W, giving you a 33.33% WI in this well. As set forth in the attached AFE, the estimated dry hole cost for the Chaco 2307-07N #409H well is \$1,560,391 with an estimated completion cost of \$3,060,204. This results in an estimated completed well cost of \$4,620,595.

If you would like to participate in the drilling of the Chaco 2307-07N #409H Well, please indicate your election in the space indicated below and return a copy of this letter to the undersigned. Please also confirm your election to participate by signing and returning the attached AFE. In the event that you elect to participate, I will forward an Operating Agreement covering the SW/4 of Section 7 – T23N-R7W for your review and execution.


