CASE 15348: Application Of WPX Energy Production, LLC For Approval Of The West Escavada Unit; Creation Of A New Pool For Horizontal Development Within The Unit Area, And For Allowance Of 330 Foot Setbacks From The Exterior Of The Proposed Unit, Sandoval County, New Mexico. Applicant seeks approval of its West Escavada Unit consisting of approximately 1,926.42 acres of Federal and Allotted Indian lands situated in all or parts of the S/2 of Section 7, the S/2 of Section 8, and all of Sections 17 and 18, Township 22 North, Range 7 West, Sandoval County, New Mexico. The unitized interval includes the Mancos formation at a depth of 3,858 feet down to the stratigraphic equivalent of the base of the Greenhorn formation at a depth of 5,695 feet as encountered in the Fulton well in Section 31, Township 23 North, Range 7 West, N.M.P.M. API No. 30-043-05164. In addition, Applicant seeks an order creating a new pool within the unitized interval for horizontal well development that will allow for wells to be located anywhere within the proposed Unit Area so long as the completed interval is no closer than 330 feet from the outer boundary of the proposed Unit. The subject acreage is located approximately 6.5 miles Southwest of Counselor, New Mexico.

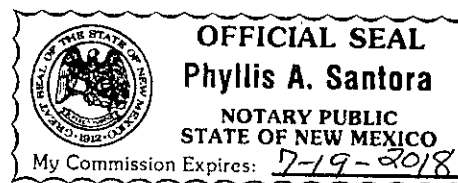
