Brad,

You may get a call from Houston Kauffman. Houston is a friend of Julian Ard and is helping Mr. Ard deal with his interest in our Maljamar prospect leases. Mr. Ard owns approximately a 10.8% WI in the Maljamar prospect and is uncommitted to the joint operating agreement. (Mr. Ard had previously entered into a term assignment with COG Operating, but the term assignment has lapsed as to everything on our acreage not in a spacing unit. COG reassigned the interest to unearned lands back to Ard in May of this year.) Long story short, we are precluded from acquiring the Ard interest by assignment. We suggested to Houston that he call you to see if Chase Oil was interested in working a deal with Mr. Ard for the interest. We are continuing with plans to compulsory pool the interest if Mr. Ard decides not to join the existing operating agreement, but would be happy to see Chase pick up that interest if you can work out a deal. I wanted to give you a heads up on the Ard interest and possible call from Houston.
